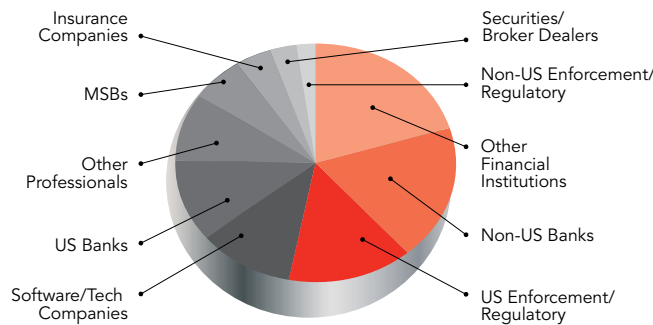

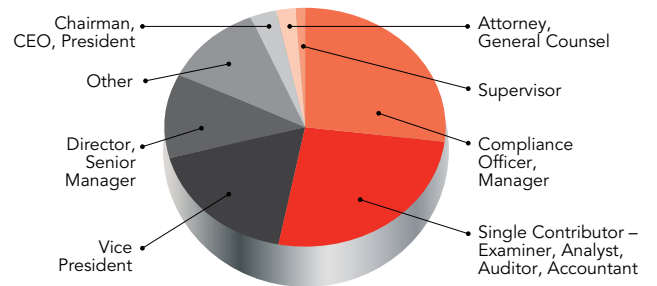
Delegates by Industry
